

Notice of Utility Tariff Filings

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Anchorage Water and Wastewater Utility (AWWU) filed TA183-122 and TA184-126, revenue requirement studies for its water and wastewater utilities, respectively, based on a 2024 test year.

With TA183-122, AWWU requests an across-the-board rate increase of 5.50 percent to the current rates for all water customers. A selection of current and proposed water rates is shown below.

With TA184-126, AWWU requests an across-the-board rate increase of 3.25 percent to the current rates for all wastewater customers. A selection of current and proposed wastewater rates is shown below.

Customer Charge (per account, all rate classes)	\$11.15	\$11.51
Unmetered Residential (per dwelling unit)	\$47.22	\$48.75
Metered Residential (per 1,000 gallons)	\$7.39	\$7.63
Metered Commercial (low strength users)	\$6.50	\$6.71
Sanitary Landfill (per 1,000 gallons)	\$2.49	\$2.57

AWWU requests that the proposed rates take effect on February 13, 2026. Should the Commission suspend TA180-122 and TA181-126, AWWU requests interim rates, subject to refund, equal to the filed proposed rates.

This notice does not contain every revision proposed and the Commission may approve a rate or classification which varies from that proposed.
